As per the Provisions laid down by the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, Act No. 33 OF 1989, dated 11/09/1989) & the Notification No. GSR – 316 (E) by Ministry of Welfare, New Delhi dated 31/03/1995 and as per the UGC Directives to be adhered and followed by the Educational Institute in this regard, following shall be the SC-ST Welfare Committee of Sipna College of Engineering & Technology, Amravati:

### **Objectives:**

This Committee shall be functioning for the following objectives of this Act.

- To implement, monitor and evaluate continuously the Reservation Policy in the Institute (if any applicable).

- There is a Advisory Committees & Special Cell at the University Level for Aid & Advice and to hear appeals if any; in this regard.
